## **SECTION 4: FIRST AID MEASURES**

#### 4.1 Description of first aid measures:

# 5.2 Special hazards arising from the substance or mixture:

As a result of combustion or thermal decomposition reactive sub-products are created that can become highly toxic and, consequently, can present a serious health risk.

Isolate leaks provided that there is no additional risk for the people performing this task. Evacuate the area and keep out those without protection. ### 6.2 Environmental precautions:
